ORDER DENYING REQUEST TO VACATE DISMISSAL

On March 21, 2023, the Michigan Office of Administrative Hearings and Rules (MOAHR) received Petitioner's email request to reschedule her hearing or vacate the Order of Dismissal issued by MOAHR on March 16, 2023, after Petitioner failed to participate in a hearing in the above-captioned matter scheduled for Thursday, March 16, 2023, at 11:00 AM. Petitioner alleges that she missed her hearing because she had another very important appointment that was scheduled on the same date and time of the hearing.

Petitioner failed to establish good cause for her failure to participate in the March 16, 2023, hearing. A Notice of Hearing was mailed to Petitioner's correct address of record and not returned to MOAHR as undeliverable. The Notice of Hearing advised Petitioner of the date and time of the hearing, instructed Petitioner how to access the hearing to participate, and stated that if Petitioner did not call in within 15 minutes of the scheduled time, the hearing may be dismissed. Additionally, the Notice of Hearing instructions advised Petitioner that she must telephone MOAHR immediately at 1-800-648-3397 or 517-335-2484 if on the day of the hearing she would be unable to participate.

NOW, THEREFORE, IT IS ORDERED that the request is **DENIED**.
