
ORDER FOLLOWING PREHEARING CONFERENCE

On July 9, 2024, a telephone pre-hearing conference was held as scheduled in the above-captioned matter. Assistant Attorneys General Kelly A. Carter and Heather L. Sneden represented the Michigan Department of Health and Human Services Expungement Unit (Respondent). Petitioner did not call in to the telephone prehearing conference.

On May 8, 2024, Petitioner and his attorney were sent a Notice of Hearing scheduling an administrative hearing for 8:30 am on July 9, 2024. Since then, Petitioner's attorney withdrew from the case and substitute council has not filed an appearance on is behalf. On June 12, 2024, an Order Converting Hearing to Prehearing Conference was issued, but the notice addressed to Petitioner's last known address was returned by the US Postal Service. Michigan Office of Administrative Hearings and Rules (MOAHR) has been unable to obtain an updated mailing address for Petitioner or contact him by telephone. No correspondence has been received from Petitioner or a representative. The prehearing conference proceeded in Petitioner's absence. Mich Admin Code, R 792.10114(8).

The hearing will proceed with an evidentiary hearing. The October 16, 2023, Order Regarding Motions In Limine remains in effect. The parties are directed to submit conflict dates for a hearing to be scheduled in **August or September of 2024**. 
A notice of hearing will be issued once a hearing date has been arranged.


