**ORDER OF DISMISSAL PURSUANT TO  
WITHDRAWAL OF HEARING REQUEST AT HEARING**

This matter is before the Michigan Office of Administrative Hearings and Rules upon Petitioner’s request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing commenced on March 14, 2024. [REDACTED], the Petitioner, appeared on her own behalf. The Department of Health and Human Services (Department) was represented by Deonna Harris, Assistance Payments Worker, and Ryan Clemons, Family Independence Manager.

The hearing was requested to dispute the Department’s action taken with respect to Medical Assistance program (MA) benefits. Shortly after commencement of the hearing, the Department confirmed that Petitioner’s MA benefits were reinstated and approved. Accordingly, Petitioner withdrew the hearing request on the record. The Department agreed to the dismissal of the hearing request.

Pursuant to the withdrawal of the hearing request filed in this matter, the Request for Hearing is, hereby, **DISMISSED**.
