WITHDRAWAL OF HEARING REQUEST AT HEARING**

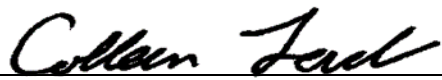
This matter is before the Michigan Office of Administrative Hearings and Rules upon Petitioner's request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing commenced on April 18, 2024. [REDACTED] [REDACTED] the Petitioner, appeared on his own behalf. The Department of Health and Human Services (Department) was represented by Errol Jackson, Eligibility Specialist, and Ahmed Elahrag, Supervisor.

The hearing was requested to dispute the Department's action taken with respect to Medical Assistance program (MA) benefits. After commencement of the hearing, Petitioner indicated there was not a need to proceed with the hearing and withdrew the hearing request on the record.
