### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on April 18, 2024, from Lansing, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by Jerice Hall. Department Exhibit 1, pp. 1-17 was received and admitted.

### **ISSUE**

Did the Department properly determine Petitioner's Medical Assistance (MA) eligibility and deductible amount?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On February 21, 2024, a Health Care Coverage Determination was sent to Petitioner informing her that she and her husband were eligible for MA-G2S with a \$3,866 deductible effective April 1, 2024. (Ex. 1, pp. 4-9)
2. On February 28, 2024, Petitioner requested a hearing disputing the determination of her MA benefit.
3. The Department provided a BRIDGES G2-FIP related MA-Net Income printout that showed how the deductible amount was calculated. (Ex. 1, pp. 16)
4. Petitioner has \$[REDACTED] in unearned income per month from social security and VA benefits. (Ex. 1, p.15)

## CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

### **Targeted Population**

The Healthy Michigan Plan (HMP) provides health care coverage for individuals who:

- Are 19-64 years of age.
- Do not qualify for or are not enrolled in Medicare.
- Do not qualify for or are not enrolled in other Medicaid programs.
- Are not pregnant at the time of application.
- Meet Michigan residency requirements.
- Meet Medicaid citizenship requirements.
- Have income at or below 133 percent Federal Poverty Level (FPL). BEM 137

With regard to the closure of MA-HMP, Petitioner has \$[REDACTED] per month income which puts the household over the income limit. Therefore, Petitioner was over the income limit for MA-HMP. BEM 137. Petitioner and her husband are also enrolled in Medicare and would not be eligible for HMP on that basis.

With regard to the approval of MA-G2S and deductible amount calculation, the Petitioner's unearned income is \$[REDACTED]. After deducting \$174.70 for insurance premiums and the \$516 protected income level, that leaves \$[REDACTED], which is the deductible amount. This was the deductible amount determined by the Department and it was proper and correct and consistent with Department policy.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's MA benefit and deductible amount.

**DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.
