**ORDER OF DISMISSAL PURSUANT TO
WITHDRAWAL OF HEARING REQUEST AT HEARING**

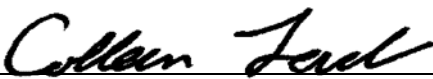
This matter is before the Michigan Office of Administrative Hearings and Rules upon Petitioner's request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing commenced on June 18, 2024. [REDACTED] [REDACTED] Authorized Hearing Representative (AHR), Community Living Services, represented the Petitioner. [REDACTED] [REDACTED] father, appeared as a witness for Petitioner. The Department of Health and Human Services (Department) was represented by Avery Smith, Assistance Payments Supervisor (APS).

The hearing was requested to dispute the Department's action taken with respect to Medical Assistance program (MA) benefits, specifically regarding whether Petitioner meets the Disabled Adult Child (DAC) criteria. After commencement of the hearing, the APS confirmed that Petitioner was approved as a DAC on May [REDACTED] 2024. Petitioner's AHR withdrew the hearing request on the record. The Department agreed to the dismissal of the hearing request.

Pursuant to the withdrawal of the hearing request filed in this matter, the Request for Hearing is, hereby, **DISMISSED**.
