# **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a hearing was held by telephone on August 28, 2024. Petitioner appeared and represented herself. The Department of Health and Human Services (Department) was represented by Princess Ogundipe, Assistance Payments Supervisor.

## ISSUE

Did the Department properly determine Petitioner's Medicaid (MA) eligibility?

# **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- Petitioner is over 65 years old, not married, and receives Retirement, Survivors, 1. and Disability Insurance (RSDI) income of \$902 per month and pension income of \$500 per month. (Exhibit A, pp. 1, 8, 13 – 14).
- 2. On May 21, 2024, the Department received a completed MA redetermination application from Petitioner. (Exhibit A, pp. 6 - 12).
- 3. On June 10, 2024, the Department sent Petitioner a Health Care Coverage Determination Notice (HCCDN) that approved Petitioner for Medicare Savings Program (MSP) - Specified Low-Income Medicare Beneficiaries (SLMB) and MA subject to a monthly deductible of \$974 effective July 1, 2024. (Exhibit A, pp. 16 -17).

4. On July 12, 2024, the Department received a request for hearing from Petitioner, disputing the amount of her monthly MA deductible. (Exhibit A, p. 4).

#### CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Petitioner requested a hearing to dispute her MA coverage. Petitioner was approved for G2S MA subject to a monthly deductible of \$974 and MSP – SLMB. Petitioner did not dispute her MSP – SLMB.

Under federal law, an individual is entitled to the most beneficial category, which is the one that results in a) eligibility, b) the least amount of excess income, or c) the lowest cost share. BEM 105 (January 2024), p. 2. All MA category options must be considered in order for the Petitioner's right of choice to be meaningful. BEM 105, p. 2. MA is available (i) under SSI-related categories to individuals who are aged (65 or older), blind or disabled, (ii) to individuals who are under age 19, parents or caretakers of children, or pregnant or recently pregnant women, and (iii) to individuals who meet the eligibility criteria for Healthy Michigan Plan (HMP) coverage. 42 CFR 435.911; 42 CFR 435.100 to 435.172; BEM 105, p. 1; BEM 137 (January 2024), p. 1; BEM 124 (July 2023), p. 1. Because Petitioner is over 65 and is not the caretaker of a minor child, Petitioner is eligible for MA under only SSI-related categories.

Based on Petitioner's circumstances, she was potentially eligible for AD-Care MA. The AD-Care program is a Group 1, full-coverage, SSI-related MA program for individuals who are income-eligible based on their MA fiscal group size. BEM 163 (July 2017), p. 1. Net income for this program cannot exceed 100% of the Federal Poverty Level (FPL) for the fiscal group size. BEM 163, p. 1. For SSI-related MA purposes, adults who are not married are a fiscal group size of one. BEM 211 (October 2023), p. 8. Petitioner testified that she is not married; therefore, she is a fiscal group of one. Because she is a fiscal group of one, to be income eligible for this program, Petitioner's monthly income would have had to be \$1,275 or less. RFT 242 (April 2024). In this case, Petitioner and the Department agree that she receives RSDI in the amount of \$902 per month plus \$500 per month in pension income. (Exhibit A, pp. 1, 8, 13 – 14). The total gross

amount of RSDI and pension is counted as unearned income but, for purposes of SSIrelated MA, is reduced by \$20 to determine the net unearned income. BEM 503 (April 2024), pp. 29 – 31; BEM 541 (January 2024), p. 3; see also BEM 163. Petitioner's RSDI and pension income of \$1,402, reduced by \$20, equals \$1,382 in net unearned income. Petitioner, who does not have earned income, expenses related to non-SSI children, or a court-appointed guardian and/or conservator, is not eligible for any additional deductions. BEM 541, pp. 1, 3. Therefore, Petitioner's countable net income was \$1,382. Because that is more than the limit for AD-Care MA, the Department properly determined Petitioner was not eligible for AD-Care MA.

Clients who are ineligible for full-coverage MA coverage because of excess income may still be eligible for G2S MA, an SSI-related MA program which provides for MA coverage with a monthly deductible. BEM 105, p. 1. The deductible for G2S MA is equal to a) the amount the individual's SSI-related net income, b) minus allowable needs deductions set forth in BEM 544, c) minus the applicable Group 2 MA protected income level (PIL). BEM 166, p. 2; BEM 541, pp. 1, 3 - 4; BEM 544 (January 2020). The PIL is a set allowance for non-medical need items such as shelter, food, and incidental expenses that is based on the county in which the client resides and the client's fiscal MA group size. BEM 544, p. 1. The PIL for Oakland County, where Petitioner resides, is \$408 for a one-person fiscal group. RFT 200 (April 2017), p. 3; RFT 240 (December 2013).

In this case, the Department presented a budget showing how Petitioner's G2S deductible was calculated and that was reviewed with Petitioner at the hearing. (Exhibit A, p. 15). From Petitioner's net income of \$1,382, the Department subtracts allowable needs deductions, consisting of health insurance premiums of the MA recipient and remedial services for residents of adult foster care (AFC) or homes for the aged (HA). BEM 544, pp. 1 - 2. No evidence was presented that Petitioner lives in AFC or HA. The evidence established that the State, through MSP, pays Petitioner's Part B Medicare premium, and there was no evidence that Petitioner pays any other health insurance premiums. Therefore, Petitioner was not entitled to any additional deductions from her net income and her countable net income remained \$1,382. (Exhibit A, p. 15). The Department then deducted Petitioner's \$408 PIL from Petitioner's \$1,382 net income, which left \$974. (Exhibit A, p. 15). This amount becomes the deductible amount. Therefore, the Department properly determined Petitioner's deductible in the amount of \$974 for July 2024 ongoing. (Exhibit A, p. 14)

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it approved Petitioner for MA with a deductible of \$974 per month effective July 1, 2024.

### **DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.
