WITHDRAWAL OF HEARING REQUEST AT HEARING**


This matter is before the Michigan Office of Administrative Hearings and Rules upon Petitioner’s request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing commenced September 17, 2024. [REDACTED] the Petitioner, appeared on his own behalf. The Department of Health and Human Services (Department) was represented by Jennipher Wheeler, Family Independence Manager (FIM).

The hearing was requested to dispute the Department’s action taken with respect to Food Assistance Program (FAP) program benefits. After commencement of the hearing, the parties confirmed that there are no longer any contested issues regarding FAP eligibility or the amount of Petitioner’s monthly FAP benefit. Accordingly, Petitioner withdrew the hearing request on the record. The Department agreed to the dismissal of the hearing request.

Pursuant to the withdrawal of the hearing request filed in this matter, the Request for Hearing is, hereby, **DISMISSED**.
