## **ORDER OF DISMISSAL PURSUANT TO STIPULATION**

On October 2, 2024, the Michigan Office of Administrative Hearings and Rules (MOAHR) received from Respondent Michigan Department of Health and Human Services (Department) a Stipulated Order that resolves the contested issues in this case.

Specifically, the Department had determined that Petitioner would have a divestment penalty of **Sector** for 20 days applied October 1, 2024 to October 20, 2024 due to allowing for notice of the negative action. However, Petitioner has waived notice of the negative action. The parties agree to resolve the contested issue by applying the 20-day penalty to the dates August 13, 2024 to September 2, 2024.

Accordingly, the 20-day divestment penalty dates shall be changed to reflect the dates of August 13, 2024 to September 2, 2024.
