**HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on December 18, 2024, from Lansing, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by Jennifer Richard. Department Exhibit 1, pp. 1-48 was received and admitted.

**ISSUE**

Did the Department properly deny Petitioner's Medicare Cost Share application for failing to be in cooperation with the Office of Child Support?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On April 15, 2024, Petitioner was approved for Plan First Medicaid.
2. On [REDACTED] 2024, Petitioner applied for FAP and MA.
3. On September 20, 2024, a Health Care Coverage Determination Notice was sent to Petitioner informing her that she not eligible for the Medicare Savings Program because she was in non-cooperation with the Office of Child Support.
4. November 8, 2024, Petitioner requested hearing raising issues with regard to her FAP and MA.
5. No one from the Office of Child Support appeared at hearing and no documents related to Petitioner's alleged non-cooperation were included in the hearing packet.

6. Petitioner's November 8, 2024, request for hearing was not timely to contest her denial of MA-AdCare and approval of MA Plan First because it was more than 90 days after the Department action.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

### **FIP and MA**

Support Specialists work for the OCS to support families by:

- Accepting referrals/applications for child support services on behalf of public assistance recipients, as well as from the general public.
- Obtaining absent parent information from clients.
- Reviewing and offering comment on good cause claims.
- Attending pre-hearing conferences and administrative hearings in support of OCS actions.
- Determining cooperation and non-cooperation (entered in Bridges via the systems interface).
- Referring appropriate cases to the local prosecutor or the FOC.

BEM 255, p.7

In this case, Petitioner's Medicare Cost Share application was denied because Petitioner allegedly was in non-cooperation with the Office of Child Support. No documents from the Office of Child Support were in the hearing packet and no one from the Office of Child Support appeared at hearing to testify as required in BEM 255. The Department

representative at hearing could not explain the basis for finding Petitioner in non-cooperation with the Office of Child Support. Therefore, the Department failed to meet their burden to establish that Petitioner was in non-cooperation with the Office of Child Support.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department failed to satisfy its burden of showing that it acted in accordance with Department policy when it denied Petitioner's Medicare Cost Share application for failing to cooperate with the Office of Child Support.

### **DECISION AND ORDER**

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Reinstate and reprocess Petitioner's Medicare Cost Share application going back to the date of application.
2. Award Petitioner Medicare Cost Share if Petitioner is found to be eligible.
