HEARING DECISION

On November 20, 2024, Petitioner, [REDACTED] requested a hearing to dispute the Department's decision to deny her application for Family Independence Program (FIP) cash assistance benefits. Following Petitioner's hearing request, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, 7 CFR 273.15, and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on January 8, 2025. Petitioner appeared and represented herself. The Department of Health and Human Services (Department) was represented by Kirstie McCaffrey, Family Independence Specialist.

A 26-page packet of documents provided by the Department was admitted collectively as the Department's Exhibit A.

ISSUE

Did the Department properly deny Petitioner's application for FIP cash assistance when it determined that Petitioner's daughter was not compliant with school attendance requirements?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED] 2024, Petitioner applied for FIP cash assistance.
2. On October 4, 2024, the Department mailed to Petitioner a Verification Checklist and a Verification of Student Information for Petitioner's daughter. The form instructed Petitioner to verify the school attendance for Petitioner's daughter by October 14, 2024.

3. On October 29, 2024, verification of school attendance for Petitioner's daughter was received by the Department and it was reported that Petitioner's daughter was enrolled as a full-time student but had ■ absences out of 45 days.
4. On October 30, 2024, the Department mailed a Notice of Case Action to Petitioner to notify her that her application for FIP cash assistance was denied because her daughter was not compliant with school attendance requirements.
5. On November 20, 2024, Petitioner requested a hearing to dispute the Department's denial.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The FIP was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Pub. L. No. 104-193, and 42 USC 601 to 679c. The Department administers FIP pursuant to 45 CFR 233-260, MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3101-.3131.

In this case, the Department denied Petitioner's request for FIP cash assistance because the Department determined that Petitioner's daughter was not compliant with school attendance requirements. Petitioner is disputing the denial.

Dependent children are expected to attend school full-time, and graduate from high school or a high school equivalency program, in order to enhance their potential to obtain future employment leading to self-sufficiency. BEM 245 (July 1, 2023), p. 1. Dependent children ages 6 through 17 must attend school full-time. *Id.* The Department is required to verify school enrollment for each child beginning at age 7 when an application for FIP is received. *Id.* at p. 11. Acceptable verification includes a completed DHS-3380 verification of student information form, verification of the organized educational program used for home schooling, telephone contact with the school, and other acceptable documentation that is on official business letterhead. *Id.* at pp. 11-12.

A dependent child aged 6 through 15 must attend school full-time. If a dependent child aged 6 through 15 is not attending school full-time, the entire Family Independence Program (FIP) group is not eligible to receive FIP. *Id.* at p. 1.


Based on the evidence presented, the Department properly denied Petitioner's request for FIP cash assistance because verification for Petitioner's daughter reported that she was enrolled as a full-time student but had 14 absences out of 45 days. Petitioner did not present any evidence that the Department improperly denied her application for FIP cash assistance based on the information that was provided to the Department.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with its policies and the applicable law when it denied Petitioner's application for FIP cash assistance.

IT IS ORDERED the Department's decision is **AFFIRMED**.
