

## ORDER OF DISMISSAL DUE TO WITHDRAWAL

Petitioner filed a hearing request to dispute an action taken by the Michigan Department of Health and Human Services (MDHHS) concerning state program benefits. MDHHS forwarded this request to the Michigan Office of Administrative Hearings and Rules (MOAHR) to schedule a hearing. Pursuant to Sections 9 and 37 of the Social Welfare Act, MCL 400.1 et seq., and consistent with Sections 71 to 87 of the Administrative Procedures Act, MCL 24.201 et seq., which govern the administrative hearing and appeal process, MOAHR was prepared to schedule a hearing in the above-captioned matter.

Prior to the hearing being scheduled, Petitioner or Petitioner's authorized hearing representative submitted a signed withdrawal of the hearing request. The undersigned has reviewed the hearing request withdrawal and, finding it consistent with policy and statutory requirements, approves it.

IT IS ORDERED that Petitioner's request for hearing in the above-captioned matter is DISMISSED.
