ORDER OF DISMISSAL
DUE TO WITHDRAWAL

Petitioner filed a hearing request to dispute an action taken by the Michigan Department of Health and Human Services (MDHHS) concerning state program benefits. MDHHS forwarded this request to the Michigan Office of Administrative Hearings and Rules to schedule a hearing. Pursuant to Sections 9 and 37 of the Social Welfare Act, MCL 400.1 *et seq.*, and consistent with Sections 71 to 87 of the Administrative Procedures Act, MCL 24.201 *et seq.*, which govern the administrative hearing and appeal process, MOAHR scheduled a hearing in the above-captioned matter. On March 19, 2025, the parties appeared at the scheduled hearing and agreed to adjourn the matter.

Prior to the adjourned hearing being scheduled, Petitioner submitted a signed withdrawal of the hearing request. The undersigned has reviewed the hearing request withdrawal and, finding it consistent with policy and statutory requirements, approves it.

IT IS ORDERED that Petitioner's request for hearing in the above-captioned matter is **DISMISSED**.
