ORDER OF DISMISSAL PURSUANT TO WITHDRAWAL OF HEARING REQUEST AT HEARING

Petitioner CAROLYN SOUTHWARD requested a hearing to dispute action taken by the Michigan Department of Health and Human Services (MDHHS) concerning Medical Assistance (MA) benefits. In response to the hearing request and pursuant to MCL 400.9 and MCL 400.37, applicable laws and regulations (7 CFR 273.15 to 273.18; 42 USC 1396(3); 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; or 45 CFR 205.10), and the Delegation of Authority from MDHHS to the Michigan Office of Administrative Hearings and Rules (MOAHR), MOAHR scheduled a hearing in the above-captioned matter. After due notice, a telephone hearing commenced on March 26, 2025. Petitioner appeared without representation. MDHHS was represented by Devona Gilbert, Hearing Facilitator.

Shortly after commencement of the hearing, Petitioner testified that a hearing was no longer necessary concerning MA benefits and withdrew the hearing request. MDHHS had no objection to the withdrawal.

IT IS ORDERED that, because of the withdrawal, the hearing scheduled in the above-captioned matter is **DISMISSED**.
