### **HEARING DECISION**

On February 28, 2025, Petitioner requested a hearing to dispute a Medicaid determination. As a result, a hearing was scheduled to be held on April 3, 2025. Public assistance hearings are held pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; 45 CFR 205.10; and Mich Admin Code, R 792.11002.

The parties appeared for the scheduled hearing. Petitioner appeared and represented himself. Respondent Michigan Department of Health and Human Services (Department) had Assistance Payments Supervisor Amanda Boobyer appear as its representative. Neither party had any additional witnesses.

Both parties provided sworn testimony, and one exhibit was admitted into evidence. A 27-page packet of documents provided by the Department was admitted collectively as Exhibit A.

# <u>ISSUE</u>

Did the Department properly determine Petitioner's Medicaid eligibility?

#### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Petitioner is not married.
- 2. Petitioner is a resident of Calhoun County.
- 3. Petitioner is disabled.
- 4. As of 2025, Petitioner receives a gross benefit of \$ per month from Social Security RSDI.
- 5. Petitioner has Medicare coverage.
- 6. Petitioner does not pay any health insurance premiums.
- 7. Petitioner does not pay for any remedial services.
- 8. Petitioner has Medicaid with a monthly deductible.
- 9. The Department determined that Petitioner's deductible was \$ per month from January 2025 through March 2025.
- 10. Petitioner has type SLMB Medicare Savings Program (MSP) coverage.
- 11. Petitioner disagrees with his Medicaid coverage.

## **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

Medicaid is known as Medical Assistance (MA). The MA program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Full-coverage Medicaid is available to eligible individuals through the Healthy Michigan Plan. In order for a client to be eligible for full-coverage Medicaid through the Healthy Michigan Plan, the client must not be qualified for Medicare coverage. BEM 137 (January 1, 2024), p. 1. Petitioner is qualified for Medicare coverage, so the Department properly determined that Petitioner was ineligible for full-coverage Medicaid through the Healthy Michigan Plan.

Full-coverage Medicaid is also available to eligible individuals through the AD Care program. In order for a client to be eligible for full-coverage Medicaid through the AD Care program, the client must be aged or disabled, and the client's group's net income must not exceed 100% of the Federal Poverty Level (FPL). BEM 163 (July 1, 2017), pp. 1-2. For AD Care, the client's group size consists of the client and the client's spouse. BEM 211 (October 1, 2023), p. 8. In this case, Petitioner's group size consists of one because Petitioner does not have a spouse. The FPL for a group size of one in 2025 is \$15,650.00. 90 FR 5917 (January 17, 2025). The applicable FPL is equal to a monthly income of \$1,304.17.

When group members receive income from Social Security RSDI, the gross amount received from RSDI is countable. BEM 163 at 2. However, \$20.00 is disregarded from unearned income such as Social Security RSDI income. BEM 541 (January 1, 2025), p. 3. In this case, Petitioner receives \$ per month from Social Security RSDI. After the \$20.00 disregard, the countable amount of his Social Security RSDI is \$ per month. Petitioner's countable Social Security RSDI is over the income limit for full-coverage Medicaid through the AD Care program. Thus, the Department properly determined that Petitioner was ineligible for full-coverage Medicaid through the AD Care program.

Since the Department determined that Petitioner was ineligible for full-coverage Medicaid through the AD Care program, the Department properly determined that the best Medicaid coverage that he was eligible for was Medicaid with a monthly deductible. Medicaid with a monthly deductible is known as Group 2 Medicaid. Group 2 Medicaid is available to clients who are aged or disabled and ineligible for full-coverage Medicaid through the AD Care program. BEM 166 (April 1, 2017), p. 1. Group 2 Medicaid eligibility is determined on a monthly basis. In general, Group 2 Medicaid provides coverage from the date a client met his deductible through the end of the month.

The next step is determining a client's needs as defined by BEM 544. A client's needs as defined by BEM 544 consists of: (1) a protected income level set by policy, (2) the cost of health insurance premiums, and (3) the cost of remedial services. BEM 544 (January 1, 2020), pp. 1-2. The applicable protected income limit for Calhoun County is only \$375.00 per month for a single individual. RFT 200 (April 1, 2017) and RFT 240 (December 1, 2013). Petitioner does not pay any health insurance premiums or costs of remedial care, so Petitioner's needs are limited to the \$375.00 protected income limit.

Petitioner's deductible is per month because Petitioner's net income of minus his needs of \$375.00 equals his monthly deductible. However, for the months of January through March, Petitioner's Social Security RSDI cost-of-living-adjustment 25-009853

(COLA) must be disregarded. BEM 503 (January 1, 2025), pp. 30-31. The 2025 Social Security COLA was 2.5%. 89 FR 85276 (October 25, 2024). Thus, Petitioner's COLA was \$ With the COLA disregard, Petitioner's deductible is \$ per month for the months of January through March. The Department properly determined Petitioner's deductible.

The Department also determined that Petitioner was eligible for Medicare Savings Program (MSP) coverage. Medicare Savings Program coverage is a type of Medicaid that helps pay costs that are not covered by Medicare. There are three basic types of MSP coverage: QMB, SLMB, and ALMB. BEM 165 (July 1, 2024), p. 1. QMB pays for Medicare premiums, Medicare coinsurances, and Medicare deductibles. *Id.* at 2. SLMB only pays Medicare Part B premiums. *Id.* ALMB only pays Medicare Part B premiums if there is sufficient funding available. *Id.* Thus, QMB is the best coverage, SLMB is the next best coverage, and ALMB is the lowest level of coverage.

The type of MSP coverage a client is eligible for is determined based on income. The income limit for QMB is the same as for full-coverage Medicaid through the AD Care program. *Id.* at 1. The income limit for SLMB is 120% of the FPL. *Id.* The income limit for ALMB is 135% of the FPL. Petitioner's countable income of \$1,315.00 per month was 101% of the FPL. Thus, the Department properly determined that Petitioner was eligible for type SLMB MSP coverage.

### **DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with its policies and the applicable law when it determined Petitioner's Medicaid eligibility.

IT IS ORDERED: the Department's decision is AFFIRMED.
