**DECISION AND ORDER**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, 42 CFR 431.200 *et seq.*, and Mich Admin Code: R 792.11002, upon the Petitioner's timely request for a hearing. After due notice, a telephone hearing was held on January 14, 2020, from Lansing, Michigan.

Petitioner, [REDACTED], appeared and represented herself. Respondent, Department of Health and Human Services (Department), had Allison Pool, Appeals Review Officer, appear on its behalf with Carolyn Malhoit, Medicaid Utilization Analyst. Neither party had any additional witnesses.

One exhibit was admitted into evidence during the hearing. A 14-page packet of documents provided by the Department was admitted collectively as the Department's Exhibit A.

**ISSUE**

Did the Department properly deny Petitioner's request for prior authorization for complete upper and lower dentures?

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner is a Medicaid beneficiary.
2. On April 26, 2016, Dental Dreams provided partial upper and lower dentures for Petitioner.
3. Petitioner's partials do not fit properly anymore.

4. On October 17, 2019, My Community Dental Clinics requested prior authorization from Medicaid for complete upper and lower dentures for Petitioner.
5. The Department reviewed the prior authorization request and determined that Petitioner had received a prior prosthesis within the past five years.
6. On November 7, 2019, the Department denied the request for prior authorization. The Department cited its reason for denial as Policy 6.6.A of the Medicaid Provider Manual, which prohibits authorization for dentures when a previous prosthesis has been provided within five years.
7. On November 22, 2019, Petitioner filed a hearing request to dispute the Department's denial.

### **CONCLUSIONS OF LAW**

The Medical Assistance Program (MA) is established pursuant to Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). It is administered in accordance with state statute, the Social Welfare Act, the Administrative Code, and the State Plan under Title XIX of the Social Security Act Medical Assistance Program.

The Medicaid Provider Manual states, "Medicaid requires prior authorization (PA) to cover certain services before those services are rendered to the beneficiary. The purpose of PA is to review the medical need for certain services." *MDHHS Medicaid Provider Manual* (October 1, 2019), Practitioner Chapter, Section 1.9, p. 4. All dentures require prior authorization. *Id.* at Dental Chapter, Section 6.6, p. 20. Complete or partial dentures are not authorized when "a previous prosthesis has been provided within five years, whether or not the existing denture was obtained through Medicaid." *Id.* at Dental Chapter, Section 6.6.A, p. 21. Further, complete or partial dentures are not authorized when lost or broken within five years. *Id.*

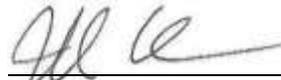
The Department acted in accordance with its policy when it denied Petitioner's request for prior authorization because billing records showed that Petitioner had been provided partial upper and lower dentures within five years of the date of the prior authorization request. Thus, Petitioner had been provided a previous prosthesis within five years of the date the prior authorization at issue here was submitted, so the Department was required to deny Petitioner's request. Even though Petitioner's partials may not fit anymore, the Department was still required to deny Petitioner's request because the Department's records showed that Petitioner had been provided dentures within five years of the date of the prior authorization request.

**DECISION AND ORDER**

The Administrative Law Judge, based on the above findings of fact and conclusions of law, decides that the Department properly denied Petitioner's request for prior authorization.

IT IS ORDERED THAT the Department's decision is **AFFIRMED**.
