DECISION AND ORDER

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 *et seq*; 42 CFR 438.400 *et seq*; and Mich Admin Code, R 792.11002.

After due notice, a hearing was held on January 14, 2020. [REDACTED] the Petitioner, appeared on his own behalf. John Lambert, Appeals Review Officer, represented the Department of Health and Human Services (Department). Carolyn Malhoit, Medicaid Utilization Analyst, appeared as a witness for the Department.

During the hearing proceeding, the Department's Hearing Summary packet was admitted as Exhibit A, pp. 1-17.

ISSUE

Did the Department properly deny Petitioner's prior authorization request for complete upper and lower dentures?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. Petitioner is a [REDACTED] year-old Medicaid beneficiary, born [REDACTED] 1959. (Exhibit A, p. 10)
2. On or about November 4, 2019, Petitioner's dental provider sought prior approval for complete upper and lower dentures. The dental provider indicated this would be the initial placement of an upper prosthesis. (Exhibit A, p. 10)

3. A beneficiary report shows that Petitioner received upper and lower partial dentures with a date of service of March 1, 2016. (Exhibit A, p. 13; Medicaid Utilization Analyst Testimony)
4. The Department denied the November 4, 2019, prior authorization request for complete upper and lower dentures because Petitioner was shown to have received upper and lower dental prosthesis within the last five years. (Exhibit A, pp. 5-10; Medicaid Utilization Analyst Testimony)
5. On November 20, 2019, the Department sent Petitioner a Notice of Denial indicating the request for complete upper and lower dentures was denied. (Exhibit A, pp. 5-6)
6. On December 6, 2019, the Michigan Office of Administrative Hearings and Rules (MOAHR) received Petitioner's Request for Hearing. (Exhibit A, pp. 4-6)

CONCLUSIONS OF LAW

The Medical Assistance Program (MA) is established pursuant to Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). It is administered in accordance with state statute, the Social Welfare Act, the Administrative Code, and the State Plan under Title XIX of the Social Security Act Medical Assistance Program.

1.9 PRIOR AUTHORIZATION

Medicaid requires prior authorization (PA) to cover certain services before those services are rendered to the beneficiary. The purpose of PA is to review the medical need for certain services.

MDHHS Medicaid Provider Manual, Practitioner
Section, (October 1, 2019), p. 4.

Under the 6.6 Prosthodontics (Removable), the Medicaid Provider Manual sets forth criteria for authorizing complete or partial dentures:

6.6.A. GENERAL INSTRUCTIONS

Complete and partial dentures are benefits for all beneficiaries. All dentures require prior authorization (PA). Providers must assess the beneficiary's general oral health and provide a five-year prognosis for the prosthesis requested. An upper partial denture PA request must also include the prognosis of six sound maxillary teeth.

Complete or partial dentures are authorized when one or more of the following conditions exist:

- One or more anterior teeth are missing.
- There are less than eight posterior teeth in occlusion (fixed bridges and dentures are to be considered occluding teeth).

If an existing complete or partial denture can be made serviceable, the dentist should provide the needed restorations to maintain use of the existing removable prosthesis. This includes extracting teeth, adding teeth to the existing prosthesis, and removing hyperplastic tissue as necessary to restore the functionality of the complete or partial denture.

Before the final impressions are taken for the fabrication of a complete or partial denture, adequate healing necessary to support the prosthesis must take place following the completion of extractions and/or surgical procedures. This includes the posterior ridges of any immediate denture. When an immediate denture is authorized involving the six anterior teeth (cuspid to cuspid), this requirement is waived.

Reimbursement for a complete or partial denture includes all necessary adjustments, relines, repairs, and duplications within six months of insertion. This also includes such services necessary for an immediate complete denture when authorized. If any necessary adjustments or repairs are identified within the six month time period but are not provided until after the six month time period, no additional reimbursement is allowed for these services.

Complete or partial dentures are not authorized when:

- A previous prosthesis has been provided within five years, whether or not the existing denture was obtained through Medicaid.
- An adjustment, reline, repair, or rebasing will make a prosthesis serviceable.
- A complete or partial denture has been lost or broken beyond repair within five years, whether or not the existing denture was obtained through Medicaid.

When denture services have commenced but irreversible circumstances have prevented delivery, the dentist should

bill using the Not Otherwise Classified (NOC) procedure code. A copy of the lab bill and an explanation in the Remarks section of the claim must be included. Providers are paid a reduced rate to offset a portion of the costs incurred. It is the expectation that the probability of removable appliances being delivered and follow up treatment completed is assessed prior to the initiation of treatment to evaluate whether the treatment is appropriate for the specific patient. Contact the Program Review Division (PRD) regarding the requirements for incomplete dentures. (Refer to the Directory Appendix for contact information.)

On or about November 4, 2019, Petitioner's dental provider sought prior approval for complete upper and lower dentures. The dental provider indicated this would be the initial placement of an upper prosthesis. (Exhibit A, p. 10) However, a beneficiary report shows that Petitioner received upper and lower partial dentures with a date of service of March 1, 2016. (Exhibit A, p. 13; Medicaid Utilization Analyst Testimony) Accordingly, the Department denied the November 4, 2019, prior authorization request for upper and lower complete dentures because Petitioner was shown to have received upper and lower dental prosthesis within the last five years. (Exhibit A, pp. 5-10; Medicaid Utilization Analyst Testimony)

Petitioner's hearing request asserted that there were problems with the work done for the initial partial dentures. The upper partial could never be made to fit. Further, Petitioner's teeth that were worked on began to break off after one week. The dentist refused to do any more work without being paid extra. (Exhibit A, p. 4; Petitioner Testimony)

The Medicaid Utilization Analyst confirmed that Petitioner would have to call the Department with a complaint regarding the prior dental services. The Department would then investigate the complaint. If the investigation resulted in that dental provider having to refund the money for the partials, Petitioner's current dental provider could re-submit the prior authorization request for the complete dentures and the five-year rule would not apply. Petitioner was given the numbers to a complaint line (517-373-4972) and the Medicaid fraud hotline (1-800-643-7283). (Medicaid Utilization Analyst Testimony)

On review, the Department's decision to deny the November 4, 2019, prior authorization request for complete upper and lower dentures was in accordance with the above cited policy. The information available to the Department showed that Petitioner previously received upper and lower partial dentures on March 1, 2016. (Exhibit A, p. 13) Under the above cited MPM policy, Petitioner was not eligible for the requested complete

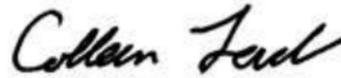
upper and lower dentures because it had been less than five years since the last upper and lower dental prostheses were provided.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, decides that the Department properly denied Petitioner's November 4, 2019, prior authorization request for complete upper and lower dentures based on the available information.

IT IS, THEREFORE, ORDERED that:

The Department's decision is **AFFIRMED**.
