HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a hearing was held via telephone conference on June 18, 2025. Petitioner appeared and was unrepresented. The Michigan Department of Health and Human Services (MDHHS or Department) was represented by Kevin Sawdon, Hearing Facilitator. Department Exhibit 1, pp. 1-58 was received and admitted.

ISSUE

Did the Department properly close Petitioner's Healthy Michigan Plan Medicaid (MA-HMP) due to excess income?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On April [REDACTED] 2025, a Health Care Coverage Determination Notice was sent to Petitioner informing her that she is not eligible for MA-HMP due to excess income.
2. On May [REDACTED] 2025, Petitioner requested hearing disputing the closure of MA-HMP.
3. Petitioner's husband earns \$[REDACTED] weekly from his employment with [REDACTED]
4. Petitioner earns \$[REDACTED] from her employment from [REDACTED] based on the check stubs provided.
5. Petitioner earned \$[REDACTED] monthly from [REDACTED].
6. Petitioner filed a new application for MA on June [REDACTED] 2025.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services

Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Targeted Population

The Healthy Michigan Plan (HMP) provides health care coverage for individuals who:

- Are 19-64 years of age.
- Do not qualify for or are not enrolled in Medicare.
- Do not qualify for or are not enrolled in other Medicaid programs.
- Are not pregnant at the time of application.
- Meet Michigan residency requirements.
- Meet Medicaid citizenship requirements.
- Have income at or below 133 percent Federal Poverty Level (FPL).

In this case, Petitioner had employment income from [REDACTED] and [REDACTED] [REDACTED] and her husband has employment income [REDACTED]. The income limit for MA-HMP for a group size of 2 is \$2,344 per month. Petitioner's household had \$[REDACTED] per month based on the check stubs provided for the previous month. Therefore, Petitioner is well over the income limit and the closure of MA-HMP due to excess income was proper and correct and consistent with Department policy. BEM 137

Petitioner testified at hearing that she stopped working one of her jobs. Petitioner filed a new application on June [REDACTED] 2025. It was explained that the new application would not be addressed as part of this hearing.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's MA-HMP due to excess income.

Accordingly, the Department's decision is **AFFIRMED**.
