### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a hearing was held via telephone conference on July 22, 2025. Petitioner appeared and was unrepresented. The Michigan Department of Health and Human Services (MDHHS or Department) was represented by Carrie Everette, Assistance Payments Worker (APW), and Cindy Wasaya, Assistance Payments Supervisor (APS).

During the hearing proceeding, the Department's Hearing Summary packet was admitted as Exhibit A, pp. 1-6 and the Department's additional documentation was admitted as Exhibit B, pp. 1-2.

### **ISSUE**

Did the Department properly stop Petitioner's State SSI Payments (SSP) benefits?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was receiving SSP benefits based on receiving Social Security Administration (SSA) issued Supplemental Security Income (SSI) benefits.
2. During a Redetermination it was found that Petitioner no longer qualifies for SSI benefits. (Exhibit A, p. 1)
3. On May 17, 2025, a Notice of State SSI Payment Change was issued to Petitioner stating the quarterly State SSI Payment has been canceled effective May 17, 2025, because the Social Security Administration notified the Department that Petitioner did not receive a regular first of the month SSI payment for three months. (Exhibit A, p. 3)
4. On May 28, 2025, Petitioner filed a hearing request contesting the Department's determination. (Exhibit A, pp. 3-4)

## **CONCLUSIONS OF LAW**

---

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The State SSI Payments (SSP) program is established by 20 CFR 416.2001-.2099 and the Social Security Act, 42 USC 1382e. The Department administers the program pursuant to MCL 400.10.

Supplemental Security Income (SSI) is a cash benefit to needy persons who are aged (at least 65), blind or disabled. It is a federal program administered by the Social Security Administration (SSA). States are allowed the option to supplement the federal benefit with state funds. In Michigan SSI benefits include a basic federal benefit and an additional amount paid with state funds. BEM 660, October 1, 2021, p. 1.

For the SSP program, payments are made for only those months the recipient received a regular first of the month federal benefit. These are shown on SOLQ as a recurring payment dated the first of the month. SSPs are not issued for retroactive or supplemental federal benefits. BEM 660, October 1, 2021, p. 1.

In this case, the Department received updated information regarding Petitioner's eligibility for SSI. Accordingly, on May 17, 2025, a Notice of State SSI Payment Change was issued to Petitioner stating the quarterly State SSI Payment has been canceled effective May 17, 2025, because the Social Security Administration notified the Department that Petitioner did not receive a regular first of the month SSI payment for three months. (Exhibit A, p. 3). The Department verified that Petitioner's SSA issued SSI benefits ended. (Exhibit B, p. 1).

Petitioner's testimony indicated that he started a job training program, which affected his eligibility for SSI. Petitioner was told the program would not affect his SSI benefits, but that has not been the case. (Petitioner Testimony). This Administrative Law Judge has no jurisdiction to review SSA's determination.

Petitioner was no longer eligible for the SSP program when he was no longer receiving SSI benefits. Accordingly, the Department properly stopped Petitioner's SSP benefits based on the information available at that time.


## **DECISION AND ORDER**

accordance with Department policy when it determined Petitioner's eligibility for the SSP program.

Accordingly, the Department's decision is **AFFIRMED**.


