**HEARING DECISION**

On June 23, 2025, [REDACTED] Petitioner’s mother/authorized hearing representative, requested a hearing on behalf of Petitioner [REDACTED] to dispute public assistance benefits. As a result, a hearing was scheduled to be held on July 29, 2025. Public assistance hearings are held pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 42 CFR 438.400 to 438.424; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. [REDACTED] appeared on behalf of Petitioner. Respondent Department of Health and Human Services (Department) had Eligibility Specialist Amy Pilto appear as its representative.

A 12-page packet of documents provided by the Department was admitted collectively as the Department’s Exhibit A.

**ISSUE**

Did the Department properly issue summer EBT (SEBT) benefits for [REDACTED]

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On May 17, 2025, the Department issued \$120.00 in SEBT benefits for [REDACTED]
2. On May 18, 2025, the Department issued a duplicate payment of \$120.00 in SEBT benefits for [REDACTED]
3. On May 19, 2025, the Department removed the duplicate payment of \$120.00 in SEBT benefits that was made in error on May 18, 2024.

4. The Department issued the SEBT benefits pursuant to guidelines that are set forth in its Frequently Asked Questions document. That document set the following guidelines:
    - a. **If your student is active FAP or TANF (cash assistance) with MDHHS the SEBT benefits will be issued to the Bridge Card associated with the active case.**
    - b. If there is no active FAP or TANF case but the student has an active Medicaid case with MDHHS, the SEBT benefits will be issued on a SEBT card and mailed to the address of the active Medicaid case.
    - c. If the student has no active MDHHS case, a new SEBT card will be sent to the address that is currently on file with the student's school.
  5. Beginning May 19, 2025, numerous transactions were made on the Bridge Card in which the SEBT benefits were issued.
  6. ██████████ had applied for and been approved to receive FAP benefits for ██████████
  7. ██████████ asserted that the SEBT benefits for ██████████ were not received.
  8. A request for hearing was submitted on June 23, 2025, asserting that the SEBT benefits for ██████████ were not received.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

This dispute involves SEBT benefits. The SEBT program is a federally funded program that provides grocery-buying benefits to low-income families with school-age children when schools are closed for the summer as a supplement to summer meal sites. BEM 619 (May 1, 2025), p. 1. A one-time lump sum benefit of \$120 per eligible child is issued. *Id.* at 2. This payment covers the months of June, July, and August. *Id.* Students are issued the SEBT benefits one of the following ways:

- 
1. Benefits for children on existing FAP, TANF, or FDPIR groups will be placed on the head of household's Bridge card associated with the case.
  2. Benefits for children in an existing MA group will be placed on a new card in the head of household's name and include all eligible children in the group.
  3. Benefits for children enrolled in the NSLP/SBP and found eligible through the SEBT application process will receive individual cards.



██████████ asserted that SEBT benefits for ██████████ were not received. However, based on the evidence presented at the hearing, \$120.00 in SEBT benefits were added to ██████████ Bridge Card on May 17, 2025. No evidence was presented to dispute the Department's action.

### **DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with its policies and the applicable law when it issued summer EBT (SEBT) benefits for Petitioner.

IT IS ORDERED, the Department's decision is **AFFIRMED**.
