HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a hearing was held via telephone conference on January 7, 2026. Petitioner appeared and was unrepresented. The Michigan Department of Health and Human Services (MDHHS or Department) was represented by Tammy Jackson, Hearing Facilitator. Department Exhibit 1, pp. 1-11 was received and admitted.

ISSUE

Did the Department properly close Petitioner's Medical Assistance (MA) case for failing to verify new employment?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On July [REDACTED] 2025, a New Hire Notice was sent to Petitioner requesting verification of employment with a July [REDACTED] 2025, due date.
2. On August [REDACTED] 2025, a Health Care Coverage Determination Notice was issued informing Petitioner that his MA was closing effective October 1, 2025.
3. On November 20, 2025, Petitioner requested hearing disputing the closure of MA.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Timeliness of Verifications

Send a case action notice when:

The client indicates refusal to provide a verification, or • The time period given has elapsed. BAM 130(May 2024)

In this case, on July █ 2025, a New Hire Notice was sent to Petitioner requesting verification of employment with a July █ 2025, due date. Petitioner did not respond to this request and his case was processed for closure. Petitioner stated that he had moved and he did not receive the New Hire Notice. Petitioner acknowledged at hearing that he did not update his address with the Department. Even without the New Hire Notice, Petitioner had an obligation to report new employment within 10 days, and he failed to do so. Therefore, the Department closure for failing to verify employment was proper and correct and consistent with Department policy. BAM 130

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioners' MA case for failing to verify employment.

Accordingly, the Department's decision is **AFFIRMED**.
