### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a hearing was held via telephone conference on January 27, 2026. Petitioner appeared and was unrepresented. The Michigan Department of Health and Human Services (MDHHS or Department) was represented by Stephanie Warner, Hearing Facilitator. Department Exhibit 1, pp. 1-23 was received and admitted.

### **ISSUE**

Did the Department properly close Petitioner's Medical Assistance (MA) case due to excess income?

### **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was a recipient of Healthy Michigan Plan Medicaid (MA-HMP).
2. On October [REDACTED] 2025, Petitioner reported new employment.
3. On October [REDACTED] 2025, a Health Care Coverage Determination Notice was sent to Petitioner informing her that her MA-HMP would be closing effective December 1, 2025, due to excess income.
4. On November 25, 2025, Petitioner requested a hearing contesting the closure of MA-HMP.
5. Petitioner earned \$[REDACTED] in employment income in 2025.
6. Petitioner's husband receives \$[REDACTED] per month in social security benefits.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services

Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

### **Targeted Population**

The Healthy Michigan Plan (HMP) provides health care coverage for individuals who: • Are 19-64 years of age. • Do not qualify for or are not enrolled in Medicare. • Do not qualify for or are not enrolled in other Medicaid programs. • Are not pregnant at the time of application. • Meet Michigan residency requirements. • Meet Medicaid citizenship requirements. • Have income at or below 133 percent Federal Poverty Level (FPL). BEM 137

In this case, Petitioner earned \$██████ in employment income in 2025. Petitioner's husband receives \$██████ per month in social security benefits. Petitioner's household has \$██████ per month in income. The monthly income limit for a group size of 2 for HMP is \$2,344. Therefore, Petitioner is over the income limit and the closure due to excess income was proper and correct and consistent with Department policy. BEM 137

### **DECISION AND ORDER**

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's MA-HMP case due to excess income.

Accordingly, the Department's decision is **AFFIRMED**.

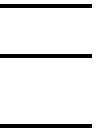
