HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a hearing was held via telephone conference on February 3, 2026. Petitioner appeared and was unrepresented. The Michigan Department of Health and Human Services (MDHHS or Department) was represented by Raichel Dennis, FIM. Department Exhibit 1, pp. 1-24 and Exhibit 2, pp. 1-6 were received and admitted.

ISSUE

Did the Department properly determine Petitioner's Medical Assistance (MA) eligibility and deductible amount?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On October [REDACTED] 2025, Petitioner submitted redetermination paperwork.
2. On October [REDACTED] 2025, a Health Care Coverage Determination Notice was sent to Petitioner informing her MA and Medicare Cost Share were closing for failing to verify assets.
3. On December 2, 2025, Petitioner requested hearing disputing the closure of MA and Medicare Cost Share.
4. At the time of hearing, Petitioner was active for Medicare Cost Share and MA-G2S with a \$[REDACTED] deductible.
5. Petitioner receives \$[REDACTED] in unearned income per month.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services

Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, with regard to the budgeting of Petitioner's MA deductible, Petitioner receives \$[REDACTED] in unearned income. After deducting the \$20 unearned income exclusion and \$38 COLA exclusion, Petitioner has \$[REDACTED] countable income. After subtracting the \$375 protected income level, \$[REDACTED] remains that is the deductible amount. This was the deductible amount determined by the Department and it was proper and correct and consistent with Department policy.

DECISION AND ORDER

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's MA eligibility and deductible amount.

Accordingly, the Department's decision is **AFFIRMED**.

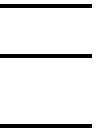
