PART 39. DESIGN SAFETY STANDARDS FOR ELECTRICAL SYSTEMS

R 408.13901 Scope.

Rule 3901. These rules establish the minimum electrical safety requirements that are necessary for the practical safeguarding of employees in their workplaces. These rules cover design safety standards for electric utilization systems and include all electric equipment and installations used to provide electric power and light for employee workplaces. The federal standards adopted by reference in R 408.13902 are divided into 8 major divisions as follows:

- (a) Electric utilization systems 1910.302.
- (b) General requirements 1910.303.
- (c) Wiring design and protection 1910.304.
- (d) Wiring methods, components, and equipment for general use 1910.305.
- (e) Specific purpose equipment and installations 1910.306.
- (f) Hazardous (classified) locations 1910.307.
- (g) Special systems 1910.308.
- (h) Definitions applicable to each division are contained in this section 1910.399.

R 408.13902. Adoption by reference of federal standards.

Rule 3902. (1) The federal occupational safety and health administration's regulations on electrical safety promulgated by the United States department of labor and codified at 29 CFR 1910.302 to 1910.308 and CFR 1910.399, Design Safety Standards for Electrical Systems, February 14, 2007 and appearing in the Federal Register, Volume 72, No 30 on pp. 7135 to 7221 are adopted by reference in these rules as of the effective date of these rules.

- (2) The adopted federal regulations shall have the same force and effect as a rule promulgated under 1974 PA 154, MCL 408.1001.
- (3) The adopted regulations are available from the United States Department of Labor, 315 West Allegan, Room 315, Lansing, Michigan 48917, at no charge as of the time of adoption of these rules, or via the internet at website www.osha.gov, or from the
